सं. ऑनिसूचि. 14/08-15-01/96-97-... यह पत्र है कि सरकारी प्रतिभूति बाजार को विकसित करने के लिए ऐसा करना जरूरी है, भारतीय रिजर्व बैंक ने 14 मई 1994 के परिपत्र सं. सीसी. सी. 136/07-01-279/93-94 द्वारा, प्राथमिक व्यापारियों को सूचीकरण की प्रणाली लागू की थी, जिसके उद्देश्य थे (क) सरकारी प्रतिभूति बाजार में 'संवेनशील', तरल और सञ्चय आधार वाले बजारों के लिए

आर्थिक संरचना को बढ़ा करना, (ख) भारतीय रिजर्व बैंक से बाहर सरकारी प्रतिभूतियों के लिए बाजार-निर्माण-क्षमताओं तथा हमीदारी का विकास सुनिश्चित करना, (ग) एक ऐसी सूचीबद्ध बाजार व्यापार प्रणाली का सुधार करना, जो दबले में, मूल्य-खोज में, तरलता बढ़ाने में और व्यापकतर निवेशक-आधार पर सरकारी प्रतिभूतियों की स्वीच्छक धारिता को प्रोत्साहित करने में सहायक हों, और (घ) खुले बाजार के माध्यम से बाजार में प्राथमिक व्यापारियों का उपयोग सहायक मातृकता के रूप में करना और संयुक्त, सहायक पर आधारित, दिनांक 29 मार्च 1995 के, "सरकारी प्रतिभूति बाजार में प्राथमिक व्यापारियों के लिए दिना-निर्देश" प्राथमिक व्यापारियों को कार्रवायियों को उचित संदर्भों के दायरे में निर्दिष्ट करने के लिए उनकी पात्रता की कमी, दायित्वों, उनकी पर्यवेक्षण-सम्बंधी प्रक्रिया, स्थितियों तथा अन्य मापदंडों को निर्धारित करते हैं।

No. A-12 (11)-8/83-Est. I(A).—In exercise of the powers conferred by sub-section (1) of section 97 read with clause (xxi) of sub-section (2) and sub-section (2-A) of that section and sub-section (2) of section 17 of the ESI Act, 1948 (34 of 1948 as amended) and in partial modification of the ESI Corporation Director (Public Relations) Recruitment Regulations 1981, except in respect of things done or omitted to be done before such modification, the Corporation hereby makes, with the approval of the Central Govt., the following Regulations regulating the method of Recruitment to the post of Director (Public Relations) in the ESI Corporation namely :—

1. Short title & Commencement :

(i) These regulations may be called the ESI Corporation Director (Public Relations) Recruitment (Amendment) Regulations, 1996.

(ii) They shall come into force on the date of their publication in the official gazette.

2. Number of Posts, Classification & Scale of Pay :

The number of posts, their classification and the scale of pay attached thereto, shall be as specified in column 2 to 4 of the schedule annexed to these regulations.

3. The method of Recruitment, Age Limit, Qualification etc.

The method of recruitment, age limit, qualifications and other matters relating to the said post, shall be as specified in column 5 to 14 of the said schedule.

4. Disqualification :

No Person :—

(a) who has entered into or contracted a marriage with a person having spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

Shall be eligible for appointment to the said posts, provided that the Director General of the Corporation, may if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of these regulations.

5. Power to relax :

Where the Director General of the Corporation is of the opinion that it is necessary or expedient so to do, he may, after taking prior approval of the Central Government and in consultation with the Union Public Service Commission, by order for reasons to be recorded in writing, relax any of the provisions of these regulations with respect to any class or category of person.

6. Residuary Matters :

Subject to the provisions of these regulations, all other regulations and instructions laid down in E.S.I. Corporation (Recruitment) Regulations, 1965 as amended from time to time, applicable to the corresponding category of officers in the Corporation, shall apply to the posts specified in the Schedule annexed to these regulations.

7. Savings :

Nothing in these regulations shall affect reservations and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, OBCs and other categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
